

Terms & Conditions for the Sennheiser Las Vegas Partner Hunt Sweepstakes at InfoComm 2026

These Terms and Conditions govern participation in the InfoComm Partner Hunt, organised by **Sennheiser electronic SE & Co. KG**, Am Labor 1, 30900 Wedemark, Germany (“Organiser”). By participating, you confirm that you accept and agree to these Terms and Conditions.

1. Organiser

The Sennheiser Las Vegas Partner Hunt Sweepstakes (“Sweepstakes”) is sponsored and organised by **Sennheiser electronic SE & Co. KG**, Am Labor 1, 30900 Wedemark, Germany (“Organiser”). The Sweepstakes is conducted in connection with a trade fair held in Las Vegas, Nevada, United States of America.

2. Eligibility

The Sweepstakes is open only to individuals who:

1. are at least 21 years of age at the time of entry;
2. are physically present in Las Vegas, Nevada, USA, during the Sweepstakes Period;
3. are legally permitted to participate under applicable U.S. federal, state, and local laws.

Exclusions:

Employees, officers, directors, contractors, and agents of the Organiser, participating partners, their respective parent companies, affiliates, subsidiaries, advertising or promotion agencies, and the immediate family members (spouse, parents, siblings, children) or household members of any such persons are not eligible.

3. Sweepstakes Period

The Sweepstakes begins and ends during the applicable InfoComm 2026 dates in Las Vegas, Nevada (the “Sweepstakes Period”). All times are local Pacific Time (PT).

4. How to Participate

No purchase, payment, or consideration of any kind is required to register or win.

Registration:

- a) Download the **Scavify** mobile app;
- b) Create a free account;
- c) Join the “**IC26 Hunt**”;

d) Complete eligible, optional tasks displayed in the app.

Tasks:

Tasks may include visiting exhibitor booths, scanning QR codes, or submitting photos or videos inside the app. All tasks are designed solely for engagement purposes and do not require the expenditure of money.

Participation is voluntary. Failure to complete any task will not result in a fee or penalty.

5. Prizes

Participants who complete eligible tasks may be considered for one or more prizes, subject to these Terms and Conditions. Prizes consist of promotional items and equipment provided by the Organiser and participating partners.

6. Winner Selection & Odds

All selection decisions are final and binding.

7. Winner Notification and Prize Delivery

Potential winners will be notified by email within approximately ten (10) business days after the end of the Sweepstakes Period.

Winners may be required to:

- confirm eligibility,
- complete an affidavit of eligibility,
- sign a liability/publicity release (where lawful),
- provide valid identification.

Selected participants must confirm their contact and delivery details within **fifteen (15) working days** of notification. If no response is received within this period, the Organiser reserves the right to select an alternative participant.

Prizes will be delivered within **sixty (60) working days** of confirmation of delivery details.

8. Taxes

All federal, state, local, and any other taxes, fees, or charges associated with prize receipt or use are the sole responsibility of the winner.

For U.S. winners, prize values may be reportable to the Internal Revenue Service (IRS), and winners may be required to complete an IRS Form W-9.

9. Use of the Scavify App

- Participation in the Sweepstakes requires use of the **Scavify** mobile application. By downloading and using the Scavify app, participants agree to Scavify's applicable **terms of service** and **privacy policy**.
 - Participants must create an account within the Scavify app to take part in the Partner Hunt and are responsible for maintaining the confidentiality of their account credentials.
 - Participants agree not to upload, capture, or display any inappropriate, offensive, or unlawful content while using the Scavify app. The Organiser reserves the right to disqualify participants for violations of this requirement.
 - Tasks completed via the Scavify app, including the capture of photos or videos, are automatically recorded by the app for the purpose of verifying task completion.
 - Scavify processes personal data, including account information, device data, and usage data (such as timestamps and location data), in accordance with its privacy policy.
 - Aggregated and anonymised data may be used by the Organiser or Scavify for analytical and reporting purposes.
 - Scavify implements appropriate technical and organisational measures to protect personal data; however, the Organiser is not responsible for the operation or availability of the Scavify platform.

10. Marketing Consent

Participants will receive **one email** relating to the administration or outcome of the Sweepstakes (for example, prize notification or confirmation).

No additional marketing communications will be sent by the Organiser or participating partners unless the participant has provided **explicit, affirmative consent** in accordance with applicable data protection laws.

11. Data Protection & Privacy

Personal data provided by participants will be processed by the Organiser for the purposes of administering the Sweepstakes, verifying eligibility, selecting winners, and delivering prizes.

Data processing will occur in accordance with applicable data protection laws, including the GDPR where applicable.

Personal data may be shared **with trusted third parties** solely where necessary for these purposes, including with:

- the Scavify platform provider,
- participating partners responsible for prize fulfilment, and
- logistics or delivery providers.

Personal data will not be used for marketing purposes unless the participant has provided explicit consent, as set out in Section 10.

Participants may withdraw from the Partner Hunt at any time. Withdrawal prior to prize selection may result in disqualification, as participation cannot be completed without the processing of the required personal data.

12. No Purchase Required

No purchase, payment, or other form of consideration is required to participate in the ISE26 Partner Hunt or to be considered for a prize. A purchase or payment will not increase the chances of receiving a prize.

13. Suspension, Modification or Termination

The Organiser reserves the right to suspend, modify, or terminate the Sweepstakes, in whole or in part, at any time if circumstances arise that are beyond the Organiser's reasonable control or that compromise the integrity, fairness, or proper operation of the Sweepstakes.

14. No Cash Alternative

Prizes are non-transferable and may not be exchanged or redeemed for cash or any other alternative, except where required by applicable law.

15. Liability

To the fullest extent permitted by law, the Organiser shall not be liable for any loss, damage, or injury arising out of or in connection with participation in the Sweepstakes or acceptance or use of any prize, except where such liability cannot be excluded by law, including in cases of wilful

misconduct or gross negligence, or for death or personal injury caused by negligence. Nothing in these Terms & Conditions limits liability that cannot be excluded under applicable law.

16. Governing Law and Severability

These Terms and Conditions and any dispute or claim arising out of or in connection with them shall be governed by the laws of the State of Nevada and applicable US-federal law, without regard to conflict-of-law principles.

Mandatory consumer protection, gaming, and promotional laws of the State of Nevada shall apply irrespective of any other choice of law.

If any provision of these Terms and Conditions is held to be invalid or unenforceable by a court of competent jurisdiction, such provision shall be severed, and the remaining provisions shall remain in full force and effect.
